

Russia-Turkey: sanctions in action

[based on the Decree № 583 of the President of the Russian Federation of November 28, 2015, Government Decree № 1296 of 30.11.2015, Government Decree № 1457 of 29.12.2015, Government Decree № 1458 of 29.12.2015]



[effective as of 27.01.2016]

The set of sanctions issued by Russia against Turkey currently in full force envisages the following **key measures**:

The ban on separate types of works (services) provision in the territory of Russia:

- construction of buildings, utility structures and specialized construction works;
- architectural activities, project engineering, technical test procedures, research and analysis;
- tourism activities and relevant services;
- hotel business;
- services to support state and municipal needs;
- woodworking.

Who are affected

- Organizations under Turkish jurisdiction
- Organizations under control of Turkish citizens
- Organizations under control of other organizations under Turkish jurisdiction

Exceptions

The ban is not applicable to works (services) that are to be accomplished under contracts signed before 30.12.2015 for effective period of these contracts.

The ban for employers on assignment of Turkish citizens to labour activity/ to works (services) execution

Exceptions

1. **Employers/customers who have been involved in labour or civil-law relations with Turkish employees as of 31.12.2015.**

NB!

- This category of employers/customers **has the right to conclude** (renew, extend) **labour agreements/services contracts after 31.12.2015** in accordance with legislation of the Russian Federation **with those Turkish employees**, who were involved in labour relations with employers as of 31.12.2015.
- Federal Migration Service authorities **have the right to** extend validity term of work permits/to issue new work permits for Turkish citizens who were involved in labour relations as of 31.12.2015 with (1) Russian legal entities, (2) organizations and private persons under jurisdiction of the Russian Federation.

2. Employers/customers included in the Exemption List (consisting of 53 organizations) approved by the Russian Government:

NB!

- Herewith, starting from 01.01.2016, the number of the employed Turkish citizens in an organization must not exceed the number of the employees involved in labour relations with an organization as of 31.12.2015.

Cancellation of visa-free regime for Turkish citizens entering Russia

From now on Turkish citizens visiting Russia (with business, tourist, and etc. purpose) have to obtain visa in accordance with the legislation of the Russian Federation.

Exceptions

- Turkish citizens, holding Russian Temporary residence permit
- Turkish citizens, holding Russian Permanent residence permit
- Turkish citizens sent to work for Turkish diplomatic and consular representative offices in Russia and their family members.
